



#### 1. Limited Warranty

DiabloSport LLC. Warrants that the Product sold hereunder will be free from defects in material and workmanship for the lifetime of the Product. DiabloSport products carry a warranty against defects in materials or workmanship. DiabloSport's liability under this warranty shall be limited to the correction or replacement of any defective part or product in question, which DiabloSport determines to be necessary; freight charges are the responsibility of the dealer distributor and/or customer. Products sold by DiabloSport are primarily for high performance, Off-road use only. DiabloSport shall not be held responsible for direct or indirect failures due to our product. This warranty is to the original purchaser and is non transferable. This warranty is void unless proof of purchase is submitted.

#### 2. Other Limits

THE FOREGOING IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURCHASE. DiabloSport LLC. does not warrant against damages or defects arising from improper or abnormal use or handling of the Product; against defects or damages arising from improper installation, against defects in products or components not manufactured by DiabloSport LLC. or its parent company Programa Inc., or against damages resulting from such products not made by DiabloSport or its parent company Programa Inc. This warranty also does not apply to products upon which repairs have been affected or attempted by persons other than employees of DiabloSport LLC or its parent company Programa Inc. unless such repairs are authorized in writing by DiabloSport LLC.

#### 3. Exclusive Obligation

THIS LIMITED WARRANTY IS EXCLUSIVE. The sole and exclusive obligation of DiabloSport LLC shall be to repair or replace the defective Product in the manner and for the period provided above. DiabloSport LLC or its parent company Programa Inc. shall not have any other obligation with respect to the Product or any part thereof, whether based on contract, strict liability or otherwise. Under no circumstances, whether based on the Limited Warranty or otherwise, shall DiabloSport LLC or its parent company Programa Inc. be liable for incidental, special or consequential damages.

#### 4. Other Statements

Oral or written statements by DiabloSport LLC Employees or representatives do not constitute warranties, shall not be relied upon by the Buyer, and are not part of the contract for sale or this Limited Warranty.

#### 5. Entire Obligation

The Limited Warranty states the entire obligation of DiabloSport LLC. with respect to the Product. If any part of the Limited Warranty is determined to be void or illegal, the remainder shall remain in full force and effect.

Most DiabloSport LLC. products have the ability to alter speed limiters. It is the buyer's responsibility to ensure that the vehicle is not driven faster than the speed rating of the tires on the vehicle in which the DiabloSport LLC. product is installed and that the maximum speed rating of the engine and or vehicle is not exceeded except in an off-road application. In no case will DiabloSport LLC or its parent company Programa Inc. be held liable if the Buyer exceeds these limits.
